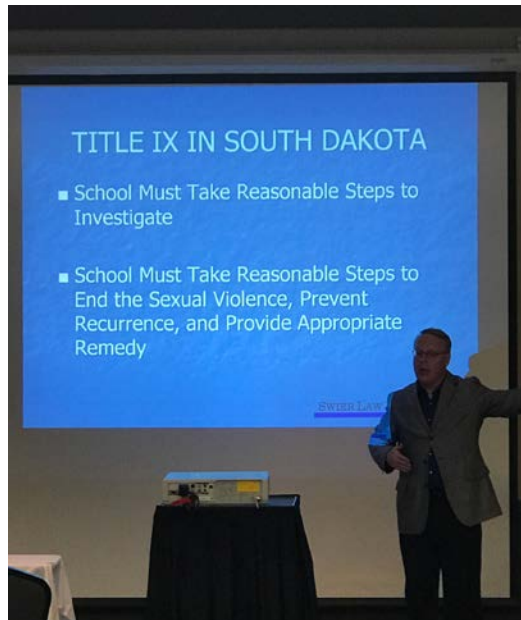

On August 10, 2017, Scott Swier addressed the Associated School Boards of South Dakota/ School Administrators of South Dakota Convention in Sioux Falls.

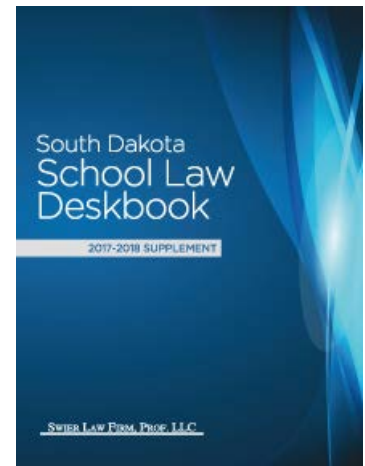

## Buffalo Balls

A Recipe from Lindsay M. Harris

### Ingredients

1lb ground chicken or turkey  
2 tbsp non-fat greek yogurt  
2 eggs  
2 tbsp chopped celery  
3 tbsp crumbled blue cheese  
1/2 tsp black pepper  
1/2 c. Frank's Red Hot Sauce

### Instructions

- Combine all of the meatball ingredients, except hot sauce, in a medium bowl. The mix will be sticky and gooey.
- Form mixture into about 1 inch balls (bite size).
- Place them on a greased cookie sheet (with sides) and bake at 350 degrees F for 10 minutes.
- After 10 minutes, remove balls from oven and dunk carefully (they are tender from the yogurt and could fall apart if you are too rough) in the buffalo sauce.
- Put back onto the cookie sheet and bake for another 12 minutes.
- If you have leftover sauce you could pour it over the meatballs and bake for another 3 to 4 minutes if you want them really saucy.
- Serve with Yogurt Based or Walden Farms Dressing for dipping.
